WAIVER OF LIABILITY & INDEMNITY AGREEMENT

Required for the use of the Alliston CRC Property

IN CONSIDERATION of being permitted to utilize the grounds of Alliston Christian Reformed Church (hereinafter referred to as Alliston CRC) for the purpose of facility rentals (as per signed rental agreement), the undersigned, for himself or herself and such participating children and/or adults and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering will inspect and carefully consider such premises. It is further warranted that such entry onto the ground of Alliston CRC for participation in such program constitutes an acknowledgement that such premises and all equipment therein have been inspected and carefully considered and that they undersigned finds and accepts same as being safe and reasonably suited for the purpose of such use by the undersigned and such children and/or adults.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE ALLISTON CRC GROUNDS FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO THE USE OF, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED, ON HIS OR HER BEHALF AND BEHALF OF SUCH CHILDREN AND/OR ADULTS, HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE ALLISTON CRC, its directors, officers, employees, and agents (hereinafter referred to as "releases") from all liability to the undersigned or such children and/or adults and all his personal representatives, assigns, heirs, and next of kin for any resulting death of the undersigned, whether caused by negligence of the releases or otherwise while the undersigned or such children and/or adults is in, upon, or about the premises or any facilities or equipment therein.
2. THE UNDERSIGNED HERBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned or such children and/or adults in, upon or about the Alliston CRC premises or in any way observing or using any facilities or equipment of Alliston CRC whether caused by the negligence of the releases or otherwise.
3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to the undersigned or such children and/or adults due to negligence of releases or otherwise while in, about or upon the premises of Alliston CRC.
4. THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER and INDEMNITY AGREEMENT is intended to be as broad and inclusive as permitted by the law of the Province of Ontario and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in the full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT on behalf of all participants and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
